

# TERMS AND CONDITIONS OF B2B RECOMMENDATION PROGRAM



## 1. Terms of program

Recommendation is successful, if a New Client, who has not made any previous purchases from our shop, registers with us and indicates that they discovered our shop through your recommendation, places an order for at least 500 EURO (with taxes) and includes your name and e-mail in the comment section while placing that order.

The order and comment must be placed in our online Shop at [www.b2b.coffeedesk.com](http://www.b2b.coffeedesk.com).

New Client must be a business company or an entrepreneur with established business activity, must pay for his order and collect ordered products.

New Client must not return ordered products or make a complaint about them within 14 days from the receiving date.

## 2. Terms of granting a prize

For 1st recommended New Client you will receive a 6% discount for your next order in our Shop and for 3rd recommended New Client you can collect a Moccamaster KBG 741 Select coffee machine.

Please keep in mind that there is no prize for 2nd recommended New Client, however you need that recommendation to eventually qualify for the prize for the 3rd New Client. The prizes are not exchangeable for money or other goods.

After you recommend 3rd New Client, we reset your recommendation count and you can start again and receive another prize for each 1st and 3rd New Client.

The discount will be granted in a form of a discount code valid for terms

of 3 months from the issue date.

The coffee machine will be delivered to you after the end date of this edition of the recommendation program. You can choose the color of the coffee machine according to our stock levels. We cover delivery costs to your address in the EU.

### **3. Your duties**

As our Partner, when recommending others to purchase from our Shop, you should:

- provide only truthful and non-misleading information about our Shop and products;
- provide information about working with us through the Recommendation Program
- display an appropriate and encouraging attitude, speak positively about us, and act in our best interests.

### **4. Non-disclosure clause**

During and after the Recommendation Program, you should keep confidential all information received from us.

In particular, this obligation applies to commercial, technological, marketing information, customer data, value of orders, number of orders, value of discount received from us, data of our employees.

### **5. End of cooperation**

The cooperation between us will end when:

- The Recommendation Program ends or we terminate it earlier;
- We terminate the cooperation with you due to non-compliance with the Terms and Condition;
- You resign from participation in the Recommendation Program; whichever of these events occurs first.

You will lose the right to the prize resulting from the order placed at the time of violation of the Terms and Conditions.

### **6. General terms**

In the event that any provision of these Terms and Conditions is found to be illegal, invalid or unenforceable, the remainder shall remain in effect and the challenged provision shall be interpreted in a manner that achieves our mutual intent.

We may ask you to provide a certificate of tax residency to comply with our tax obligations, however as a business owner You are solely responsible for your tax liabilities.

Any disputes arising from the implementation of the Recommendation Program will be resolved amicably. For litigation disputes, the competent court shall be the court of the seat of Coffeedesk. To the extent not regulated, the provisions of the Polish Civil Code shall apply.

We will process your personal data in accordance with our privacy policy and GDPR rules in order to perform our duties under these Terms and Conditions.
